Dear Secretary Blinken,

I write to you today to express my appreciation for the leadership and support that the Biden Administration has demonstrated towards our ally, Israel, since the terrorist attacks of October 7, 2023. Your commitment to Israel's security and right to self-defense resonates strongly with the shared democratic values of our two countries.

While recognizing Israel's legitimate security concerns and its right to defend its citizens against Hamas, I believe it is also imperative that we address the disturbing death toll and humanitarian crisis affecting the Palestinian people in Gaza. It is essential that our strategies encompass a dual approach: one that ensures Israel's security and sovereignty and another that alleviates the suffering of innocent Palestinian civilians.

I am confident that under your leadership, the U.S. State Department can make meaningful progress in achieving these objectives. It is crucial that we work towards a future where both Israelis and Palestinians can live in peace and security, free from fear and violence. Both groups have rightful claims to establish and maintain their own states in their ancestral land. Your role in navigating this conflict will be a pivotal step towards lasting stability in the region.

Thank you for your continued commitment to this complex and significant issue.
